

ORDER AND RESOLUTION
SETTING THE 2025 TAX RATES FOR
FORT BEND COUNTY EMERGENCY SERVICES DISTRICT NO. 10

In Open meeting on the 8th day of September, 2025, the Board of Emergency Services Commissioners of Fort Bend County Emergency Services District No. 10 ("ESD 10") convened to conduct a public hearing on a proposed 2025 tax rate increase and to consider and take action to adopt the 2025 Tax Rates for ESD 10 Maintenance and Operations Fund, and Interest and Sinking Fund, and made findings and adopted orders as set forth below:

WHEREAS, as provided under Section 775.074, Health & Safety Code, the ESD 10 Board of Emergency Services Commissioners shall annually impose an ad valorem tax on all taxable real and personal property located in ESD 10 for ESD 10's support and to achieve the purposes authorized by Chapter 775, Health & Safety Code; and

WHEREAS, the 2025 ad valorem tax rates for ESD 10 are:

Proposed Tax Rate:	\$0.096400/\$100
No-New Revenue Tax Rate:	\$0.093104/\$100
Voter Approval Tax Rate:	\$0.096507/\$100

and,

Whereas the proposed tax rate exceeds the No-New Revenue Tax Rate and therefore constitutes a tax rate increase - but does not exceed the Voter Approval Tax Rate - as provided under Chapter 26, Tax Code ESD 10 must conduct a public hearing on the proposed tax rate of \$0.0964/\$100; and

WHEREAS, ESD 10, conducted a public hearing on the proposed 2025 tax rate of \$0.0964/\$100; and

WHEREAS, it is necessary and appropriate for ESD 10 to levy a 2025 ad valorem tax on each \$100.00 valuation of all taxable real and personal property located in ESD 10; and

WHEREAS, ESD 10 has adopted a budget for the 2026 fiscal year,

After review, Motion was made by Commissioner **CYRUS** seconded by Commissioner **BUZEK** to approve the adoption of a 2025 ad valorem Tax Rate of **\$0.09640/\$100** on all taxable real property and personal property in ESD 10, and the following Order,

IT IS HEREBY ORDERED by the Board of Emergency Services Commissioners of ESD 10, that the Board of Emergency Services Commissioners of ESD 10 hereby adopts and levies the following tax rates for 2025:

Maintenance and Operations tax rate (General Fund):	\$0.0964/\$100
Interest and Sinking tax rate (Debt Service Fund):	<u>\$0.0000/\$100</u>

THIS TAX RATE THAT WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

THE TAX RATE WILL EFFECTIVELY BE RAISED BY 3.54 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$3.30.

The Notice of Public Hearing on the proposed Tax Rate Increase notifying the public of the date, time and place of the public hearing was published by ESD 10 in The Fort Bend Herald, on August 28, 2025.

The Fort Bend County Tax Assessor-Collector, as the Fort Bend County Emergency Services District No. 10 Tax Assessor-Collector, is hereby authorized to assess and collect the Fort Bend County Emergency Services District No. 10 ad valorem taxes on all taxable real property and personal property as established in this Order and Resolution.
