

**FORT BEND COUNTY EMERGENCY SERVICES DISTRICT NO. 10
RESOLUTION OF THE BOARD OF COMMISSIONERS
ACCEPTING CANVASSING ORDER OF THE ELECTION RETURNS OF
THE NOVEMBER 4, 2025 SALES AND USE TAX ELECTION IN FORT
BEND COUNTY EMERGENCY SERVICES DISTRICT NO. 10 AND
IMPLEMENTING A ONE PER CENT (1%) SALES AND USE TAX**

WHEREAS, on July 14, 2025, the ESD Board of Commissioners ("ESD Board") of Fort Bend County Emergency Services District No. 10 ("ESD 10") ordered a sales and use tax election for the ESD 10 jurisdiction to be held on November 4, 2025 (the "Election"), at which the following proposition was submitted to the ESD 10 voters in accordance with the law:

The adoption of a local sales and use tax in Fort Bend County Emergency Services District No. 10 at the rate of one per cent (1%).

WHEREAS, the Election was held on November 4, 2025, jointly with Fort Bend County at all Fort Bend County polling places as designated by Fort Bend County and set forth in the ESD 10 Notice of Election; and

WHEREAS, the official returns of the Election have been canvassed by the ESD 10 Canvassing Authority as required by law and the election results have been certified to the ESD Board,

THEREFORE, BE IT ORDERED BY THE BOARD OF COMMISSIONERS OF FORT BEND COUNTY EMERGENCY SERVICES DISTRICT NO. 10 THAT:

1. The Election ordered by the ESD Board, was duly and regularly called, notice thereof given and the Election was conducted on November 4, 2025, all as provided in the Order and Supplemental Orders Calling the Sales and Use Tax Election.
2. The returns of the Election were provided to the Canvassing Authority of the ESD Board by the officers of the Election as provided by the Texas Election Code, as amended.
3. It is hereby found and declared that the ESD 10 voters cast ballots in the Election in the number of votes indicated:

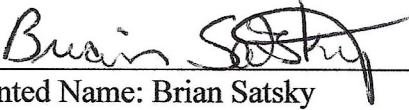

The results of the Election were declared and are hereby confirmed that a majority of the votes cast in the ESD 10 Sales and Use Tax Election voted "Against" Proposition "A," thereby not authorizing ESD 10 to impose within the ESD 10 jurisdiction a local sales and use tax at a rate of one percent (1%), within the ESD 10 jurisdiction.
5. This Resolution and the canvassing order and materials shall be maintained and held in the ESD 10 records in accordance with applicable provisions of the Texas Election Code

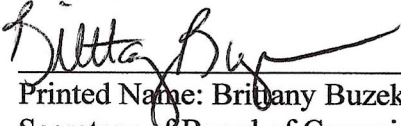

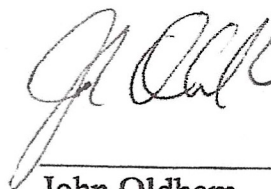

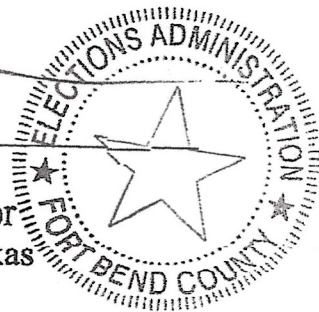
CANVASS
